In order to be apart from the legal risks caused by the illegal data sharing against the law, and especially in order to provide the security of your personal data, our Company reserves its right to request additional document and information from you (such as TR ID Card information or the copy of your driving license, etc.).

I give my consent for the protection of my personal data that I've provided in this application form under the law 6698 and the evaluation of my application in accordance with the 13th Article of the Law, its reply, my application to be delivered to myself, and my data to be processed by your Company in a limited manner for the purposes of the detection of my identity and my address.
